President's Message

Dear Meadowood Family,

This past year was one that we will always remember. When looking back, it is important that we consider all that transpired in 2020. Of course, the pandemic will always be in the forefront when we contemplate what occurred in our lives during the year. However, the bigger story is how we faced the challenges we encountered amid a worldwide health crisis. Fortunately, Meadowood entered this crisis as a strong and unified community. The unity and strength in the Meadowood culture were the solid foundation that propelled us through this year of unimaginable circumstances. While our focus was directed to COVID-related challenges, we never lost sight of the need to provide our residents with a safe and engaged lifestyle and our staff with a safe and supportive workplace. I am so proud of the Meadowood team and what we were able to accomplish while facing such a virulent virus. Listed below are some of the more notable achievements in 2020:

- Implemented the Caremerge communication system, allowing us to effectively communicate with residents, families, employees, and Board.
- Achieved a five-star rating from CMS (Centers for Medicare and Medicaid Services).
- Eliminated agency for staffing, realizing a budget savings of over \$425,000.
- The PA Department of Health completed three focused infection control surveys. There were no deficiencies identified on any of these surveys.
- Enhanced team pride and autonomy during the pandemic, creating an environment conducive to and supporting positive culture change throughout the Meadowood staff. This was especially apparent in the Health Center.
- Developed a comprehensive COVID-19 preparedness and response plan.
- Maintained a high-quality dining program. Provided daily meal delivery to 350 residents. Provided in-room meal service for all levels of care in the Health Center.
- Secured a \$2,300,000 PPP (Paycheck Protection Program) loan and applied for forgiveness. Received \$900,000 funding from the Cares Act.
- 2020 was a record-setting year for the annual appeal, as we raised \$290,000. We had a 52% participation rate of residential living households. We are deeply touched by the generosity and kindness of our donors during a challenging year.
- Created extensive virtual programming to create an environment of community engagement in a time of significant lifestyle restrictions to keep the community safe.
- Honored resident Bill Fox for his commendable contributions to our community at our annual Founders' Day celebration in March.
- Successfully closed out the Grove Project. There was outstanding teamwork and cooperation from all throughout the project. The Grove Project was completed on time and below budget.
- The walking trail project was another success which proved to be an extremely valuable asset for the community, especially during the pandemic.
- In the meantime, we advanced two critical components of the master plan. The whole site generator has been ordered, and the Memory Care project, pending final financial review, is on track for a June 2021 groundbreaking.
- Although we continued to pursue elements of our Master Plan, we put a hold on all other non-essential capital spending during the pandemic. This created significant savings in our capital budget and insured a positive position in our cash flows.

These are only some of the highlights of our successful operations during these most unprecedented times. The sense of community was never more evident than what we experienced in 2020. It was clear that every resident, employee, and Board member were united to maintain the highest level of care for all who experienced the Meadowood Community, which was our greatest accomplishment

BOARD OF DIRECTORS

Philanthropy is deeply rooted in our culture at Meadowood, starting with the founders providing the space for us to develop this community. Giving has played an essential role in making possible our achievements of the past and our plans for the future.

On behalf of the Board of Directors, I extend our gratitude to all the benefactors, including donors and volunteers recognized in this annual report, and to all donors who have given to Meadowood throughout the years. I urge you to continue your absolutely vital participation and invite others to join us in our effort to make Meadowood the best it can be.

The Board is ever mindful of what a privilege it is to serve our community of caring people, supported by such a competent, compassionate, and energetic staff. The Management Team and Board of Directors maintain a consistent vigilance over residents' welfare with a commitment to ensure that Meadowood continues to fulfill the worthy purpose declared in our mission statement.

RESIDENTS ASSOCIATION

All Meadowood residents are members of the Meadowood Residents Association (MRA), which was created to give residents a voice in community governance in partnership with management and the Board of Directors. The Resident Council consists of twelve elected members (five officers, the past president, and six members-at-large), which are the governing body of the MRA. A non-elected resident Corporate Accountant oversees all treasury operations. The Council meets monthly. It also holds three general meetings, called Stated Meetings, each year – in January, May, and September. The MRA Council President serves as a non-voting member of the Meadowood Board and, in that capacity, works cooperatively with the Board.

The MRA enriches life in our community by sponsoring over 60 activities, which address the interests and educational needs of residents. Resident volunteers create, organize, and direct all these activities, which include - but are not limited to - various arts and crafts, gardening, sports, trip opportunities, publications, chorus, entertainment programs, and study groups.

The MRA receives voluntary contributions from residents to fund these activities through its annual Spring Appeal, which also raises money for service awards for our graduating high school seniors. A second MRA appeal takes place in November. Funds collected are used to recognize the outstanding service Meadowood employees give to our residents throughout the year. These gifts are distributed at the employee holiday party in December.

Funds are also raised through community-wide activities, which support the Meadowood Benevolence Fund. Other activities that raise money for the Benevolence Fund and/or special projects approved by the Resident Council include the Gosling's Nest Gift Shop, Hidden Treasures Thrift Store, Beading, Crafts, Ceramics, and the Woodshop. In addition to volunteering on committees, residents show their neighborly values by volunteering in the Health Center to assist residents and patients. Their skills and time are greatly appreciated.

The MRA is an active partner in creating and evolving the lifestyle of our community. Residents of all ages use their talents and knowledge to make living at Meadowood a rich and fulfilling experience.

STEWARDSHIP

Stewardship is a way of life at Meadowood. We celebrate the commitment and dedication of our donors and volunteers, who give of their time, talents, and treasures. Meadowood is a strong community, thanks to your support and our responsible planning and management of resources. Meadowood is proud to be a good steward of the contributions we receive, and we are truly grateful for your generosity and trust in us. Thank you for choosing Meadowood to be the recipient of your charitable giving.

Over the past five years, donors have generously contributed gifts and bequests of \$2.1 million to Meadowood, with \$580,000 of that total received in 2020. These donations allow us to continue to enhance our mission to provide the highest quality of life for all who experience the Meadowood Community.

BENEVOLENCE **F**UND — Each year donations are designated to help build the Benevolence Fund, which gives residents peace of mind should they experience unexpected financial challenges or outlive their resources. Throughout the years, grants have been provided to 25 residents who were not able to pay the full cost of their care. Grants of \$305,384 were awarded in 2020 to five residents.

RESTRICTED GIFTS – These restricted gifts benefited many programs and areas of campus, exemplifying how donors take pride in the Meadowood Community. To show their appreciation of the heroic efforts of employees, many residents and Board members sponsored breakfasts, lunches, and other special treats. The employees appreciated these generous contributions.

As the walking path was completed, residents sponsored benches around the path to honor or memorialize loved ones. These benches provide nice respite for walkers and a place to enjoy the natural surroundings. Other gifts of time and money continue to be used to improve the Nature Preserve, including completing our second round of planting 500 trees in five years, for a total of over 1,000 trees. Both these types of donations make a profound impact on our environmental wellness program.

A sizeable gift was made in memory of a loved one for the patio area by the Grove, named "The Gathering Place." Residents will be able to enjoy a beautiful, serene outdoor garden patio, which nurtures environmental, spiritual, and social dimensions of wellness. Another environmental gift was restricted for a permanent outdoor shade structure in the Stratton Family Wellness Garden. This will help enhance programming in the picturesque garden, as we will be able to hold events in the rain and bright sun. The shade structure will help residents and staff utilize this beautiful space more often.



SILVER LININGS IN THE PANDEMIC CLOUDS

As this Annual Report is being written, our post-COVID world is emerging—slowly, gradually, joyfully—as we unmask, dine together, socialize, even hug! There were some very good things to come out of the dark days of 2020.

For Meadowood's Fitness and Wellness Department, the best thing to come out of the darkness was innovation. We created unique programming for the "Six Dimensions of Wellness"—physical, emotional, vocational, spiritual, intellectual and social.

Early on, we recognized a need to keep people moving in order to keep them healthy. We created videos that could be uploaded to the Meadowood Intranet and played on the in-house TV channel—workouts for all levels, from seated chair aerobics to balance class, tai chi and yoga, as well as offerings for those with Parkinson's—that allowed our residents to exercise in their own residences. Exercise-at-home sheets, fitness bands, hand weights and yoga mats were delivered directly to the homes of anyone who requested them.

Hallway workouts were popular among our Health Center residents; for others there were our twice-daily wellness walks in the Stratton and Woodland gardens. Many times, we donned winter coats and took a stroll outside to combat cabin fever and stretch our legs. When the weather cooperated, outdoor courtyard workouts throughout the campus became hugely popular, with residents socially distanced under covered walkways and exercising just outside their doors. When the weather improved, some of our classes moved outside.

Intellectual stimulation came in the form of Zoom meetings and conference call offerings, with residents connecting to socialize and learn remotely. As we expanded programming on the in-house channel, people tuned in for community news, interviews with staff and residents, different health or wellness issues. And our game shows became the stuff of senior-living legend.

To focus on the emotional dimension, masked and safety-conscious in-home wellness visits and personal training helped those struggling with social isolation. Our pen pals program sought to connect our residents with members of the wider community, including children and teachers from local schools.

Spiritual needs were bolstered by outdoor morning prayer and afternoon meditation.

The "Pandemic Expressions" project appealed to our artistic residents as they decorated wooden puzzle pieces with artwork, poetry, photos, images, and words that served to capture their pandemic experience. The pieces were then assembled into a cohesive piece of art and hung in the pool lobby for all to see.

Social events included traveling happy hours with a variety of themes, complete with signature cocktails, trivia and games, as well as small-group outdoor mixers on the patio.

Who knew the limitations of a pandemic could be so liberating? And while we hope never to have to live through anything like COVID-19 again, we've realized we can't label the experience as all bad, because some (very) good came out of it. Our silver linings will shine on here at Meadowood for a very long time.
